Muiriosa Foundation policies and procedures have been developed to promote safe environments for children and young people; to mitigate the potential for risk to arise; and to manage it safely where it does. The policies and procedures outlined in this Child Safeguarding Statement apply to all Muiriosa Foundation staff (employees, students, trainees, volunteers, contractors and any person performing any role or function in, or on behalf of, the Muiriosa Foundation). - o Integrated Risk Management Policy to assess and manage any risk of harm;
- Accident/Incident Management policy to inform HSE management of any incident where a child has been harmed whilst availing of the service.

The Muiriosa Foundation has established Governance Structures which supports and monitors the implementation of Children First across the Muiriosa Foundation.

Implementation

All staff, local and senior managers and DLP's are responsible for ensuring that the policy and procedures are operating effectively.

Child Safeguarding Statements must be developed across Muiriosa Foundation family support/respite and pre-school services.

This Child Safeguarding Statement will be reviewed annually, or as soon as practicable after there has been a material change in any matter to which the statement refers.
